

Subject: Educational Excellence

SO-PEs,

Eighth Western Rivers has been selected as one of three districts to beta test the E-Directorate's new Educational Excellence program. This program is designed to improve the capabilities of our instructor cadre nationally by giving them a means of assessing their effectiveness in the classroom and receiving an acknowledgement for reaching a higher standard.

I have enclosed a couple documents that outline the details of the program. The power point document is the presentation on the Educational Excellence program endorsed by NEXCOM and presented at NACON. The word document is a summary of the process and the evaluation form.

On the Education Directorate's web page, all copies of WayPoints can be found. These have been sent to all district leaders and all DSO-PE officers since January for distribution to the flotilla level including all instructors. The WayPoints documents provide some valuable tips on improving instructor competence based on proven techniques.

This is the first step and it is entirely voluntary. Eventually it will become part of an ongoing qualification process. Not everyone will embrace this but we all know instructors who need to improve their delivery in a public safe boating session.

It is our hope the SO-PE group can champion this process and give us valuable feedback as it develops. Please assure this reaches all of the instructors in your respective divisions and feel free to contact Wilson Allsbrook or me with any questions.

I offer my sincere appreciation to those of you who are willing to mentor and instructor through this improvement process.

Educational Excellence Program

Purpose - It is critical that Coast Guard Auxiliary instructors demonstrate a high level of professionalism. To that end they should be coached and challenged to continuously improve their skills. The Educational Excellence Program is designed to challenge our instructors to improve their efficiency in instructional delivery skills and to provide appropriate acknowledgement of such performance improvements. The program is designed to assist our 5400 instructors to improve their presentation skills. This achievement will be recognized for a period of two years, after which the instructor may choose to go through the process again.

Relevance to Strategic Plan – The RBS mission is identified as a key mission in both the Coast Guard and Coast Guard Auxiliary Strategic Plans. Consistent with these plans, the Education Directorate and the Training Directorate of the Coast Guard Auxiliary have developed a Way Forward for Education that involves the improvement of present course offerings, development of online courses, and the creation of a Professional Development Program for our instructor cadre. The Educational Excellence Program is part of the Professional Development Program.

Recognition – The instructor who completes this process after (insert date) will be authorized to attach an "E" to the Instructor ribbon. A certificate will also be issued. Instructors are encouraged to repeat this process every two years.

Process

a) The primary evaluation tool for this program is a video recording of the instructor teaching a public education or member training session. The session must be be tween 30 and 60 minutes in length and can be recorded in any convenient format. The focus is not on creating a world-class film, but rather simply recording the les son for later review by the instructor.

There are many relevant and important skills for instructors, including (but not limited to) front end analysis, course development, text and examination writing, crafting PowerPoint presentations, presenting course materials, and analysis of examination results. All of these are potentially relevant in terms of instructor development and certification. The focus of the EE program is solely on the improvement of the presentation skills of our existing instructor cadre. This is because our PE instructors will be presenting material developed by others.

- b) Instructors are encouraged to review the recent issues of WAYPOINTS, to prepare for this process.
- c) The focus of the video recording shall be on the instructor as opposed to broad shots of the students. This also simplifies the video recording process.
- d) The video recording must then be self-critiqued by the instructor, identifying strengths, effective strategies, and areas for growth and improvement. A check sheet is attached and shall guide the instructor's self-assessment. Relevant guidance on effective presentation techniques is provided in various issues of WAYPOINTS.
- e) The video and self-critique must be submitted to a designated Education Examiner for review and feedback. Helpful and constructive feedback and recommendations f or improvement must be provided to the instructor.
- f) A second video must then be made and re-submitted for review. A conference shall be held between the Education Examiner and the Instructor to provide additional feedback and recommendations.
- g) Finally, the Education Examiner will attend a class (PE or MT) presented by the In structor and score the presentation. A total score for the 10 attributes (see below) of 45 or more is required to qualify for this award.
- h) Once this process is complete, the attached form shall be completed and submitted to the DIRAUX.

Education Examiners

Education Examiners will be designated by DIRAUX upon the review and recommendation of the DCO. This can be a district specified process that involves any combination of the DSO-PE, DSO-MT and the OTO. It will be critical to have a sufficient number of Educational Examiners available to provide local access with minimal travel demands.

Educational Examiners should be:

Experienced instructors who are current in the IT qualification Strong presenters who model quality instruction Positive role models who possess strong interpersonal skills

Additional Notes

Exemplary videos should be shared with the National Education and National Training Directorates as examples of best practices.

References

The attached references along with the recent issues of WayPoints will serve as quality guidance for Auilixarists as they work through this program.

Ideally the process should be standardized across all Districts. This flexibility is provided to avoid unduly burdensome requirements for geographically dispersed districts.

Staying Safe When Outdoors

Many of us are entering the <u>coldest time of the year</u>. Cold temperatures make your body lose heat faster than it can be produced. This condition results in abnormally low body temperature, also known as hypothermia.

Hypothermia affects the brain, leaving the victim unable to think clearly or move well. This inability makes hypothermia particularly dangerous because a person may not know it's happening. Victims of hypothermia are often:

- Seniors with inadequate heating, food or clothing;
- Babies sleeping in cold rooms; and
- People who remain outdoors for long periods like the homeless, hikers or hunters.

In extreme cold, make outside trips as brief as possible to protect your health and safety. However, if you must be outside <u>take a few special precautions</u>:

- Dress warmly and in layers. A waterproof jacket will help you stay warm and dry if it starts to snow;
- Work slowly if you have to do heavy outdoor chores; and
- Notify friends and family where you will be before you go hiking, camping or skiing.

Do not ignore shivering. It is an important first sign that the body is losing heat. <u>Learn the other signs</u> of hypothermia and how to care for someone who may be suffering from it before your next outdoor winter excursion.
