Commander's Notes October 2020



Workshops for 2020- Surface, Air and Telecommunications Wed, 01 Jan 20

Important: The Surface Operations Workshop is Required for 2020

The Surface Operations workshop is mandatory in 2020 for all coxswains, boat crew, personal watercraft operators (PWO), paddle craft operators, and associated trainees. This workshop must be completed by June 30, 2020. If not completed by that date, program participants shall be regarded as not current in their competency, shall not be authorized to be assigned to duty to perform those program activities, and shall be placed in Required Workshop Not Met (REWK) status.

The workshops for the Air and Telecommunications teams are **strongly recommended** for 2020.

These workshops can be given by any Auxiliarist qualified in the respective operations area for that workshop. This course needs to be taught by or under the supervision of an Auxiliary certified instructor.

Because of COVID-19 safety protocols WEBINAR delivery of these training sessions as well as the 2020 TCT/Risk Management workshop has been authorized by <u>ALAUX 004/20</u> and <u>ALAUX 011/20</u> respectively.
